**PAYMENT TERMS**

All accounts are due and payable in full within THIRTY (30) days of each invoice date, unless otherwise agreed to in writing by Brandt Ag. Products, LLC (BAP). All past due principal is subject to an annual finance charge of fifteen percent (15%) or one and one-quarter percent (1.25%) per month. Customers who do not pay within the expressed terms and conditions contained herein agree to reimburse BAP for all collection costs incurred by BAP including, but not limited to, attorneys fees, expenses and court costs.

I authorize BAP to contact the financial and trade references listed on Credit Application to obtain verity and re-verify credit information. I further authorize the bank references listed on Credit Application to release basic credit information to BAP.

This Agreement shall be governed by the laws of the State of California. The parties agree that all disputes or actions arising under this Agreement shall be commenced, prosecuted and concluded in the Superior Court of the Sate of California in and for the County of Santa Barbara and not elsewhere. Each party specifically waives any objections to venue in Santa Barbara County.

Upon termination of the Agreement by either party, all principal and interest shall be immediately due and payable and interest on said sum shall accrue at the gate of 15% per month until paid in full.
